

DESIGNATION OF SUBCONTRACTORS

Bidders shall state the portion of work by trade (electrical, painting, etc.) that each subcontractor will perform. Additionally, the Bidder shall state the name and business address for all designated subcontractors. Failure to provide this information in a legible manner may result in the rejection of an otherwise acceptable bid.

In compliance with the provisions of sections 4100 to 4113, inclusive, of the Public Contract Code of the State of California, and any amendments thereof, each Bidder shall set forth below the name and the location of the mill, shop, or office of each subcontractor who will perform work or labor or render service to the Bidder on, in, or about the construction of the work or improvement to be performed under these specifications and the portion of the work which will be done by each subcontractor. In addition, effective July 1, 2014, pursuant to Assembly Bill 44 (AB 44), Contractors are required to list the license numbers of all subcontractors required to be listed below. AB 44 provides a grace period of twenty four hours after bid opening for Bidders to provide subcontractor license numbers that were omitted or incorrect as of the time of bid opening. Further, pursuant to SB 854, only subcontractors who have registered with the California Department of Industrial Relations (DIR) and who are current in paying the annual renewal fee to the DIR shall be eligible to perform work on the project resulting from this bid process.

If the Bidder fails to specify a subcontractor for any portion of the work to be performed under the contract, the Bidder shall be deemed to have agreed to perform such portion itself, and it shall not be permitted to subcontract that portion of the work except under the conditions hereinafter set forth.

Subletting or subcontracting of any portion of the work as to which no subcontractor was designated in the original bid shall only be permitted in cases of public emergency or necessity, and then only after a finding reduced to writing as a public record of the legislative body of the District.
