Application for Appointment

Background: On November 8, 2022, the Sequoia Union High School District passed Measure W, a \$591.5 million bond measure to update and modernize schools in the district. The District now seeks interested community members to become part of its Citizens' Bond Oversight Committee (CBOC). The purpose of the CBOC is to keep the public informed of the District's expenditure of bond revenues and to report on the expenditure of taxpayer funds to ensure they are spent only for permissible purposes. The District anticipates that the CBOC will meet about 4 times per year. The CBOC is subject to the Ralph M. Brown (Open Meetings) Act. You need not live within the District's boundaries, but all applicants must have an interest in our community.

Instructions: Interested applicants must complete this form and submit it to the Sequoia Union High School District, office of the Superintendent, by **March 27, 2024**. Applicants may be contacted for further follow-up or interview. Applicants may apply for an "At-Large" position or may apply to meet one of the categories described below. The District anticipates appointing 7 individuals to its CBOC.
