13 students will travel to Pinnacles National Park on March 7-8, 2015, for an overnight car camping trip with the Stanford Outdoor Outreach Program (SOOP).

Menlo-Atherton High School

6 Boys' Golf Team members will travel to Glendora on March 7-9, 2015, to compete in the Glendora Invitational Golf Tournament.

5 Boys' Golf Team members will travel to Fairfax on March 22-23, 2015, to compete in the Wildcat Golf Tournament.

g. ADOPTION OF RESOLUTION NO. 1538, FOR LAND USE COVENANT AND OPERATION AND MAINTENANCE AGREEMENT FOR MYRTLE STREET, EAST PALO ALTO (by roll call vote)

SITUATION

On January 15, 2014, the Board approved the Lease-lease Back agreement with Charles Pankow Inc., to construct the new two-story, 11-classroom building at 980 Myrtle Street in East Palo Alto. Part of this work involved soil mitigation for hazardous soils containing high levels of pesticides. The mitigation was partially removing soils and capping soils onsite with asphalt and hardscape work.

Because soil mitigation was under the oversight of the Department of Toxic Substance Control, the district is required to enter into a land use covenant as well as an operation and maintenance agreement with the California Department of Toxic Substances Control. Resolution No. 1538 and the documents referenced above are included with the background materials; they have all been reviewed by legal counsel.

FISCAL IMPACT

No impact to the General Fund; all costs paid by state-matching funds.

RECOMMENDATION

That the Board of Trustees adopts Resolution No. 1538, for the Land Use Covenant and Agreement, and the Operation and the Maintenance Agreement Between SUHSD and the California Department of Toxic Substances Control for 980 Myrtle Street in East Palo Alto.

h. APPROVAL OF CONTRACT FOR ENVIRONMENTAL TESTING SERVICES (consent)

SITUATION

Kellco Services, Inc. has been retained by both the Construction and Maintenance departments during fiscal year 2014/2015 for the purpose of providing a full spectrum of environmental surveying and testing services, as well as monitoring air quality for the possible existence of mold, asbestos and/or lead district-wide. Included with the background materials is the contract with Kellco Services, Inc. not to exceed \$60,000.

FISCAL IMPACT

Monies will be allocated as needed to Deferred Maintenance, Measure "A" and state-matching funds.

RECOMMENDATION

That the Board of Trustees approves the contract with Kellco Services, Inc. for environmental testing services.

i. REPORT ON DISTRICT CONTRACTS UNDER \$35,000 (info/consent)

SITUATION

Per Board Policy 3312, Contracts, the Board of Trustees authorizes the Superintendent or his/her designee to approve all contracts up to \$35,000. The Superintendent is required to submit a comprehensive list of all contracts approved under his authorization to the Board of Trustees for ratification.

FISCAL IMPACT

RECOMMENDATION

That the Board of Trustees ratifies the district contracts under \$35,000.

j. APPROVAL OF CONTRACT FOR SERVICING HEATING, VENTILATION, AND AIR CONDITIONING EQUIPMENT (consent)

SITUATION

Southland Industries will provide labor and material for installation of new or replacement Heating Ventilation and Air Conditioning (HVAC) equipment, preventative maintenance, cleaning and repair services on AERCO boiler/heater units, CSI INET 7 control system, software programming district-wide and freezer/cooler units in Food Service at the district office. Included with the background materials is the contract with Southland Industries. The cost of services is not to exceed \$50,000.

FISCAL IMPACT

\$21,922.70 will be paid by the General Maintenance Fund and \$28,077.30 will be paid by the Cafeteria Fund

RECOMMENDATION

That the Board of Trustees approves the contract with Southland Industries for servicing HVAC equipment.

k. APPROVAL OF CONTRACT FOR RESTORATIVE JUSTICE CIRCLE FACILITATOR AND MEDIATION SERVICES (consent)

SITUATION

During the first quarter of the 2014-2015 Academic Year, East Palo Alto High School invested 7-8 hours per week for Remi Sobomehin to work as Restorative Justice (RJ) Facilitator. This position was created with the mission of providing proactive and reactive Restorative Justice support to help create a community and culture based in understanding and compassion, while setting and maintaining a standard of excellence in relationships and personal responsibility. Concurrently, the mission of this contracted position is to reduce the number suspensions by 10% each year for three years.

Mr. Sobomehin will:

- Host Harm Circles to help students restore the community after they have inflicted various forms of harm.
- Conduct teacher/student mediations
- Conduct RJ Interventions
- Complete RJ Check-ins after mediations have been completed to ensure students are holding to their agreements
- Provide peer mediations
- Complete reports and monitor contracts so that student/program progress can be tracked.

Due to LCAP funding increase, EPAA increased the hours for this role to a minimum of 15 hours a week (and will increase again in the spring) to invest more time in proactive Restorative Justice, including assisting teaching the Restorative Justice class, which trains 15 students to lead mediations and harm circles. Through identifying underlying emotional motives in their own actions and helping students practice taking responsibility for their behavior, students are prepared to collaborate with the EPA Youth

Court to lead harm circles and RJ mediations. Remi Sobomehin also will be working with the Student Government to create a culture that proactively creates a peaceful school community.

FISCAL IMPACT

Cost: \$37,000 paid from LCAP (\$20,000) Morgan Stanley grant to Stanford New Schools for After School programs (\$17,000)

RECOMMENDATION

That the Board of Trustees approves the contract with Remi Sobomehin for Restorative Justice facilitation services at East Palo Alto Academy.

1. APPROVAL OF CAHSEE WAIVERS (consent)

SITUATION

The State Board of Education adopted regulations that govern the administration of the California High School Exit Examination (CAHSEE) to provide a waiver procedure that would allow certain disabled students to utilize test modifications. Senate Bill 1476 moved the waiver process for the CAHSEE to the local level by giving local governing boards the authority to grant such waivers. This waiver is required for disabled students who took one or both portions of the CAHSEE with a modification and attained the equivalent of a passing score on the test(s). On March 2, 2005, the Board of Trustees approved CAHSEE Waiver Procedures, including required documentation, that are based upon state-developed eligibility criteria.

The Board is asked to review the waiver request of two Sequoia students who attained the equivalent of a passing score on the Math and/or the ELA test with the use of modifications. For purposes of confidentiality, the waiver application is provided to the Board under separate cover. The Director of Special Education has reviewed the waiver request and required documentation, and she has certified that the student has met all state and board requirements and is eligible for waiver of the requirements.

FISCAL IMPACT

None

RECOMMENDATION

That the Board of Trustees approves the CAHSEE waivers requested.

 MOPTION OF RESOLUTION NO. 1539, NON-REEMPLOYMENT OF PROBATIONARY CERTIFICATED EMPLOYEE (by roll call vote)

SITUATION

Education Code 44929.21 states the governing board shall notify the probationary certificated employee on or before March 15th of the employee's second complete consecutive school year of employment in the district of the decision to reelect or not reelect the employee for the next succeeding school year. The school administration has determined not to re-elect the probationary employee listed on the attached resolution (employee number to appear in official minutes). The governing board must take action in order for notices on non-reelection to be presented to the employee on or before March 15, 2015.

FISCAL IMPACT:

None

RECOMMENDATION:

That the Board of Trustees adopts Resolution No. 1539, release of designated probationary certificated staff.

n. AUTHORIZATION TO HIRE ARCHITECT FOR MENLO-ATHERTON INTERIM HOUSING PROJECT AND FIRE SUPPRESSION IMPROVEMENTS (consent)

SITUATION

On June 25, 2014, the Board approved entering into Master Planning Contracts with architectural firms, including LPA, Inc. Staff is preparing for the Phase 1, G-Wing Project at Menlo-Atherton High School.

The existing G-Wing buildings (11 classrooms) will be demolished this summer in order for the new project to proceed. The new project is to build a twenty-one (21) 2-story classroom building.

The interim modular classrooms are required to replace demolished classrooms and will consist of twelve (12) modulars. Three (3) will be purchased and nine (9) will be leased until the new classroom building is complete.

It is necessary to hire LPA Inc., to provide architectural services and construction administration for the interim housing project. In addition, LPA Inc will provide services to improve the fire suppression systems on campus which will be needed for the new classroom building. The total cost for these architectural services is \$92,000. Proposal is provided in the background materials.

FISCAL IMPACT

No impact to General Fund: The costs will be paid by Measure A bond funds.

RECOMMENDATION

That the Board of Trustees authorizes the Superintendent to hire LPA, Inc. in the amount of \$92,000 to provide architectural services for the Menlo-Atherton High School Interim Housing project and fire suppression system improvements.

o. APPROVAL OF CONTRACT FOR DIFFERENTIATION INSTRUCTION AND COMMON CORE STATE STANDARDS FOR EAST PALO ALTO ACADEMY TEACHERS (consent)

SITUATION

The Elevated Achievement Group, Inc. will work with the East Palo Alto Academy(EPAA) teachers on differentiated instruction and the Common Core State Standards implementation. The purpose of this work is to provide professional development to EPAA in the implementation of the Common Core State Standards (CCSS) and differentiated instruction.

The professional development sessions will include face-to-face training sessions on the CCSS and differentiation, in-classroom coaching support and observational walks utilizing the EAG Achievement WalkTM tool to both create a benchmark for current instructional practices as well as provide evidence of change in practice due to the professional development.

CCSS—Impact on Curriculum in ELA/Literacy and Mathematics

This professional development will focus on the effective elements of planning CCSS ELA/Literacy and Math instructional units. Participants will look at unit assessments that align with the Smarter Balanced Assessments and understand the impact of effective unit planning to align instruction to meet the assessment content and context requirements.

Participants will:

- Understand the standards and their development.
- Understand content and context requirements of unit assessments as a formative assessment tool.
- Understand how to develop ELA/Literacy and Mathematics CCSS instructional units to meet summative assessment outcomes.
- Plan and create an instructional units designed to meet needs of diverse learners in untracked classrooms.

CCSS—Impact on Differentiated Instruction and Delivery in ELA/Literacy and Mathematics

This professional development will focus on the elements of effective ELA/Literacy and Math CCSS lesson design that are designed to meet the needs of all diverse learners.

Participants will:

- Understand the elements of an effective lesson that addresses all diverse learners.
- Understanding the elements of a lesson that is sequenced to include gradual release from the teacher to independent work by the student.
- Participate in a model lesson that demonstrates the elements of effective CCSS instruction, differentiation and effective instructional delivery.
- Plan and deliver effective CCSS literacy lessons that recognize the needs of diverse learners through thoughtful differentiation.

In-Class Coaching Support

Following the initial delivery of the professional development sessions, EPAA will be provided with inclassroom coaching support. This coaching support is designed to support teachers in the implementation of the learned content, emphasizing the common core standards and the needs of diverse learners, covered during face-to-face sessions. There are a variety of levels that can occur during this application stage: coplanning and co-presenting by both the expert and the stakeholder, co-planning by both but presenting by the stakeholder, planning and presenting by the stakeholder as the expert observes and offers feedback and suggestions. This application stage can also be scaffolded to first focus on the content, then the process, with eventual integration of the content and process. All of this support takes places in the actual setting of implementation.

EAG Achievement WalkTM tool

EAG also utilizes our Achievement WalkTM tool to provide continuous evaluation that is grounded in student achievement. Achievement WalksTM will be conducted in buildings to assess the application of learned content in school and classroom practice. This data is used to both assess application as well as to inform the quality of the professional development and to determine specific stakeholder needs.

FISCAL IMPACT

\$40,000 to be funded by a grant to EPAA from the Eustace-Kwan Family Foundation.

RECOMMENDATION

That the Board of Trustees approves the contract with Elevated Achievement Group, Inc. for Differentiation Instruction and Common Core State Standards for East Palo Alto Academy teachers.

a. PRESENTATION AND DISCUSSION OF THE STRATEGIC PLAN

SITUATION

Over the course of the 2014-15 school year the district has undertaken the development of a new Strategic Plan. On August 13, 2915, Pivot Learning Partners proposed a process that was approved by the Board on September 3. The duration of September was spent in five stakeholder input sessions, as well as individual sessions with Board members.

On October 7 and 21 the input received was analyzed at Strategic Planning Committee meetings, with big ideas compiled from this analysis. In addition, the Strategic Planning Committee decided to survey the community for a broader base of input. A sub-committee of the Strategic Planning Committee developed the survey, which was completed by 2,539 stakeholders in November. The Strategic Planning Committee met on December 2 to disaggregate the survey data, to compare and contrast it into the big ideas that came out of the October committee meetings. The Strategic Planning Committee then charged the sub-committee with taking the group's findings for further review and then drafting a plan. The sub-committee met on December 11 and January 15 to this end and a draft was shared with the Strategic Planning Committee. On January 22, the sub-committee met to incorporate the Strategic Planning Committee's directions.

The resulting draft was sent out to the Strategic Planning Committee, which met to review and then approved the plan on February 3. This approved draft is included with the background materials and will be presented to the Board on February 18, 2015.

Based upon the outcome of the Board discussion, the draft Strategic Plan will either be brought to the Board for adoption on March 4 or sent back to the Strategic Planning Committee with recommendations for edits/changes/additions.
